Sub: Creation of 06 nos. of Regular Posts of Teachers in Govt. Secondary Schools from the year 2016-17 in abolition of equal nos. of Contractual posts hold by the Teachers engaged in different Government High Schools.

Sir,

In accordance with the principles enunciated in this Department Resolution No.14546/SME dt.25.07.2011, I am directed to convey the sanction of Governor for creation of 06 nos. of regular posts of different categories as mentioned in the statement enclosed (Annexure-I),in abolishing equal nos. of Contractual posts hold by the concerned Teachers as created in this Deptt. Office Order No. 3981/S&ME dt.26.02.2008.

The above 06 nos. of regular posts in the respective scales are created for regularization of the Contractual Teachers as mentioned in the statement enclosed.

The regularization is made as per the conditions laid down in this Department Resolution No.14546/SME dt.25.07.2011 in the pre revised pay scale of Rs.9,300-34,800 with Grade Pay of Rs.4,200/- (pre-revised) corresponding to the level-9 for the TGT posts, Rs.9,300-34800 with Grade Pay of Rs.4,200/- (pre-revised) corresponding to the level-9 for the Classical (Sanskrit) / Hindi posts having requisite training qualification and Rs.5,200-20,200/- with Grade Pay of Rs.2,800/- (pre-revised) corresponding to the level-8 for TI / Untrained classical (Sanskrit)/ Hindi posts, Rs.5,200-20,200/- with Grade Pay of Rs.2,200/- (pre-revised) corresponding to the level-6 for the TM post in the appropriate Level & Pay Cell of the Pay Matrix under Odisha Revised Scale of Rules, 2017, subject to following conditions:

- i)The selections of these teachers were made in regular process following ORV Act.
- ii)The Screening Committee headed by the Collectors of the concerned Districts had found them suitable for regularization.
- iii) The DSE shall verify thoroughly the eligibility of each & every case before issue of the order in their favour on the principle of completion of uninterrupted and satisfactory service of six year in respect of the aforesaid 06 nos. of contractual Teachers.

Further, it is to clarify that the Untrained Classical teachers engaged prior to 27.10.2014 having requisite qualification as per this Department Resolution No. 17542/SME dt.05.09.2011 shall avail the pay scale of Rs.9300- 34,800/- with Grade

pay of Rs.4200/- and the corresponding to level-9 in the revised scale in the pay matrix as above in pursuance to S&ME Department Letter No.19866/SME dt.29.09.2016 after regularization of their services.

The charge is debitable to "Demand No.10-2202-General Education-Administrative Expenditure-Establishment, Operations and Maintenance Expenditure-02-Secondary Education-109-Government Secondary Schools-1261-Secondary Schools-01003- Salaries (voted)" in the Financial Year 2018-19.
