- 3. Two third of the members including Chairman shall form the quorum.
- 4. All Reports for Private Higher Secondary Schools as well as Private Secondary Schools/ High Schools shall be forwarded by Director, Higher Secondary Education and Director, Secondary Education by online/ offline mode to Government in School & Mass Education Department for preparing agenda and convening meeting for consideration/ approval of the High Power Committee.

Director, Higher Secondary Education, Odisha shall place the matter in respect of Higher Secondary Schools and Director, Secondary Education, Odisha shall place the matter in respect of High Schools before the Committee.
