In pursuance to Sub-Section 3(b) of Section 4 of Odisha Education Act, 1969 (Odisha Act, 15 of 1969) provides that the State Government may "permit any person and body of persons, to establish and maintain educational institution and recognize such institutions when so established in accordance with the provisions of this Act" and Section 5 of this Act also speaks about the permission for establishment of educational institutions.

In pursuance of the above provisions of the Act., the State Government in supersession of School and Mass Education Department Notification No.19951/SME dated.06.11.2010 and in partial modification of Higher Education Department Notification No.15641/HE dated.01.05.2004 and this Department Notification No.551/SME dated.09.01.2017 do hereby re-constitute a Committee consisting of following members for grant of permission and recognition to Private Higher Secondary Schools and Private Secondary Schools/ Private High Schools irrespective of medium of instruction for the whole state, namely:-

- 3. Two third of the members including Chairman shall form the quorum.
- 4. All Inspection Reports for Private Higher Secondary Schools as well as Private Secondary Schools/ High Schools shall be forwarded by Director, Higher Secondary Education and Director, Secondary Education by online mode to Government in School & Mass Education Department within the statutory period for scrutiny, preparing agenda and convening meeting for consideration/ approval of the High Power Committee.
- 5. Director, Higher Secondary Education, Odisha shall place the matter in respect of Higher Secondary Schools and Director, Secondary Education, Odisha shall place the matter in respect of High Schools before the Committee.
