Sub:- Recommendation of NCPCR on implementation of Section-29 of RCFCE, Act, 2009  
Sir,

In inviting reference to this Department letter No. 12918/SME, dt. 24.06.2019 on the aforesaid subjected, I am directed to say that as per section 29 (1) of RCFCE Act, 2009, the NCPCR u/s 13(1) (a) has recommended the following points for its proper implementation:

i) To revoke the curriculum developed by CISCE and prescribed in their schools with immediate effect and ensure the implementation of section 29 (1) of the RTE Act, 2009 in each and every school of the State.

ii) All schools affiliated to CISCE and defined under section 2(n) of the RTE Act, 2009 including Central schools/ schools affiliated to Central Board follow the curriculum (syllabus, textbooks) and evaluation procedure given by NCERT/SCERT, as the case may be and follow above procedure failing which NOC be withdrawn by the State Education Department.


iii) The schools be directed to display the directions on school's website and notice board. A copy of directions be circulated and disseminated by the schools among parents for information.

iv) No child shall be discriminated and/or harassed and/or neglected by the school for carrying books published/prescribed by the academic authority (NCERT/SCERT) causing "mental or physical suffering". Any action taken against the child and hence, may attract the provisions of Juvenile Justice Act, 2015.

You are, therefore, requested to circulate the recommendations of Hon'ble NCPCR among the schools affiliated under CISCE under intimation to this Deptt. and ensure its proper implementation.




