Kudumulugumma 3. Khairput 4. Mathili and Balimela N.A.C. coming under Malkangiri-I Education District.

There are 650 nos of Rev. Villages and 64 of Grampanchayats under Malkangiri-I Education District. Schooling facility have been provided to the children in age group of (6-11) and (11-14) in 540 nos of primary and 170 nos of U.P.(M.E.) Schools in 710 nos of villages.

The District Inspector of Schools is the head within the Education District to Inspect and Supervise to field functionaries Primary and U.P.(M.E.) Schools run by the Education Department for better improvement of the day to day running of the School Education. Besides, there are 10 S.I. of Schools under the control of this education to inspect and supervise the field functionaries to Primary School Teachers in respect of their S.I.s Circle for day to day smooth running of the school education for qualitative of education of the school going children.

The Govt. have given the financial power to authority concern has empowered to draw and disburse salaries to all employees working under his control.

The Officer appointed for development of education is this education district are performing their duties and responsibility assigned to them for public interest to rout out illiteracy and ignorancy.


