NOTIFICATION

Bhubaneswar, dated the 23rd March 1998

S. R. O. No. 111/98—Whereas the draft of certain rules further to amend the Orissa Aided Educational Institutions (Non-Government Fully Aided Primary School Teachers') Retirement Benefit Rules. 1986 was published as required by sub-section (1) of section 27 of the Orissa Education Act, 1969 (Orissa Act 15 of 1969), in the extraordinary issue No. 587 of the Orissa Gazette, dated the 7th June 1996, under the notification of the Government of Orissa in the School & Mass Education Department No. 17670-SME, dated the 7th June 1996 as S.R.O. No. 347/96 inviting objection and suggestion from all persons likely to be affected thereby till the expiry of a period of thirty days from the date of publication of the said notification;

And whereas no objection or suggestion has been received on the said draft within the period so specified by the State Government;

Now, therefore, in exercise of the powers conferred by section 27 read with sub-section (1) of section 10 of the said Act, the State Government do hereby make the following Rules further to amend the Orissa Aided Educational Institutions (Non-Government Fully Aided Primary School Teachers') Retirement Benefit Rules, 1986, namely:—

- 1. (1) These rules may be called the Orissa Aided Educational Institutions (Non-Government Fully Aided Primary School Teachers') Retirement Benefit (Amendment) Rules, 1998.
 - (2) They shall be deemed to have come into force with effect from the 1st day of September 1988.
- 2. In the Orissa Aided Educational Institutions (Non-Government Fully Aided Primary School Teachers') Retirement Benefit Rules, 1986 (hereinafter referred to as the said rules), in sub-rule (1) of rule 2, after clause (f), the following new clause (f-1) shall be inserted, namely:—
 - "(f-1) "Family Pension" means the family pension payable under rule 8";
- 3. In the said rules, for rule 8, the following rule shall be substituted, namely :-
 - "8 (1) An employee shall be eligible for pension, gratuity or death-cum-retirement gratuity and T. I. at the rate admissible to his counter-part in State Government service.
 - (2) The family of an employee, including the employee who retired or died on or before the commencement of these rules, shall be entitled to get family pension and T. I. as admissible to the family of his counter-part in the State Government service".

NOTIFICATION

S. R. O. No. 112/98—Whereas the draft of certain rules further to amend the Orissa Aided Educational Institutions Employees' Retirement Benefit Rules, 1981 was published as required by sub-section (1) of section 27 of the Orissa Education Act, 1969 (Orissa Act 15 of 1969), in the Extraordinary Issue No. 588 of the Orissa Gazette, dated the 7th June 1996, under the notification of the Government of Orissa in the School & Mass Education Department No. 17672-S.M.E., dated the 7th June 1996 as S.R.O. No. 348/96 inviting objection and suggestion from all persons likely to be affected thereby till the expiry of a period of thirty days from the date of Publication of the said notification;

And whereas no objection or suggestion has been received on the said draft within the period so specified by the State Government;

Now, therefore, in exercise of the powers conferred by section 27 read with sub-section (1) of section 10 of the said Act, the State Government do hereby make the following rules further to amend the Orissa Aided Educational Institutions 'Employees' Retirement Benefit Rules, 1981, namely:—

- 1. (1) These rules may be called the Orissa Aided Educational Institutions' Employees' Retirement Benefit (Amendment) Rules, 1998.
- (2) They shall be deemed to have come into force with effect from the 1st day of September, 1988.
- 2. In the Orissa Aided Education Institutions Employees' Retirement Benefit] Rules, 1981 (hereinafter referred to as the said rules) in rule 2, in sub-rule (1),—
 - (i) after clause (e), the following new clause shall be inserted, nemely:-
 - (e-i) "family pension" means the family pension payable to the family of an employee under rule 8; and
 - (ii) in clause (f) for the words and brackets "Director of Public Instruction (Higher Education)" the words and comma "Director, Higher Education" shall be substituted.

- 3. In the said rules, in rule 8, for sub-rule (2) including the Notes 1 and 2 thereunder, the following sub-rule and Note shall be substituted, namely :---
- "(2) (a) An employee shall be eligible for pension if he has completed not less than ten years of qualifying service up to the date of his retirement. The maximum period of qualifying service to be taken into account for the purpose of pension shall not exceed thirty-three years. The maximum pension shall be at the rate of fifty per cent of the last month's pay drawn by the employee.
- (b) The family of an employee including the employee who retired or died on or before the commencement of these rules, shall be entitled to get family pension as admissible to the family of nis/har counter-part in the State Government service.

NOTE—For the purpose of calculating the pension and gratuity, only completed years of qualifying service shall be taken into account and fraction of a year shall be ignored. In calculation of the pension under this rule, the formula applicable to State Government employees shall be followed".
