S. R. O. No. 54/2001—Whereas the draft of certain rules further to amend the Orissa Aided Educational Institutions' (Non-Government Fully Aided Primary School Teachers') Retirement Benefit Rules, 1986, was published as required by Section 27 read with sub-section (1) of Section 10 of the Orissa Education Act, 1969 (Ori-sa Act 15 of 1969) in the extraordinary issue No. 1170 of the Orissa Gazette, dated the 16th August 2000, under the notification of the Government of Crissa in the School and Mass Education Department No. 18430, dated the 30th June 2000 bearing S. R. O. No. 485/2000, inviting objections and suggestions from all persons likely to be affected thereby, till expirey of a period of fifteen days from the date of publication of the said notification in the Orissa Gazette;

And whereas no objection or suggestion has been received by the State Government during the period so specified in respect of the said draft;

Now, therefore, in exercise of the powers conferred by Section 27 read with Section 10 of the said Act, the State Government do hereby make the following rules, namely:--

- 1. (1) These rules may be called the Orissa Aided Educational Institutions' (Non-Government Fully Aided Primary School Teachers') Retirement Benifit (Amendment) Rules, 2000.
 - (2) They shall come into force on the date of their publication in the Orissa Gazette.
- 2. In the Orissa Aided Educational Institutions' (Non-Government Fully Aided Primary School Teachers') Retirement Benifit Rules, 1986, in sub-rule (1) of rule 6, after the words "all previous services rendered", the brackets and words "(including the period in ervice training, if any, undergone by the employee)" shall be inserted.

S. R. O. No. 602/2001—Whereas the draft of certain rules further to amend the Orissa Aided Educational Institutions' (Non-Government Fully Aided Primary School Teachers') Retirement Beenefit Rules, 1986 was published as required under sub-section (I) of Section 27 of the Orissa Education Act, 1969 (Orissa Act, 15 of 1969) in the extraordinary issue No. 1173 of the Orissa Gazette, dated the 21st June 2001 under the notification of the Government of Orissa in the School and Mass Education Department No. 13449—XIVE-Codes-64/2000-S&ME., dated the 17th May 2001 bearing S. R. O. No. 276/2001 inviting objections and suggestions from all persons likely to be affected thereby, till the expiry of a period of fifteen days from the date of publication in the Orissa Gazette;

And whereas no objection and suggestion has been received on the said draft within the period specified by State Government.

Now, therefore, in exercise of the Powers conferred by Section 27 of the said Act, the State Government do hereby make the following rules rurther to amend the Orissa Aided Educational Institutions (Non-Government Fully Aided Primary School Teachers') Retirement Benefit Rules, 1986 namely:—

- 1. (1) These rules may be called the Orissa Aided Educational Institutions' (Non-Government Fully Aided Primary School Teachers') Retirement Benefit Amendment Rules, 2001.
 - (2) They shall deemed to have come into force on the 1st day of September 1988.
- 2. In the Orisea Aided Educational Institutions' (Non-Government Fully Aided Primary School Teachers') Retirement Benefit Rules, 1986, for sub-rule (2) of rule 8, the following sub-rule shall be substituted namely:—
- "(2) The family of a pensioner or family of an employee who died on or after the 1st September 1988 shall be entitled to get family pension and T. I. as admissible to the family of his counterpart in the State Covernment Service".
