
Sub: Regarding Counting of ex-Local Board/District Board Service as qualifying service for pension.

Sir,

I am directed to say that the benefit of counting of ex-Local board/District Board service towards pension has been extended in favour of non Government fully aided Primary Schools Teachers who have retired between 1.4.82 and 4.9.89. vide this Department letter No.SMEXII/2000-21982/SME dtd.9.08.2001. Since the Primary School Teachers who have retired prior to 1.4.82 and after 4.9.89 are deprived of such benefit, now in order to obviate discrimination, it has been decided that the period of service rendered under Ex-Local Board /Ex-District Board by fully aided Primary School Teachers who have retired prior to 1.4.82 and after 4.9.89 (after being declared as Government Servant w.e.f 5.9.89) will count towards pension.


This has been concurred in by Finance Department vide UOR No.26CSIIIdtd 5.2.11.
