Sub : Rationalization of Elementary Teachers / Zilla Parishad Teachers/ Siksha Sahayaks for the year 2010-11.

Sir

The Right of Children to Free and Compulsory Act^{has} come into force w.e.f. 1st April, 2010. The Act envisages that the appropriate Govt. and local authority shall ensure to maintain the pupil teacher ratio as per the norms and standards prescribed in the schedule. A copy of the schedule is enclosed for reference.

In order to arrive a school wise PTR of 30 : 01 at the primary level and 35 : 01 at the upper primary level with a minimum of two teachers per school rationalisation of all category of teachers and Siksha Sahayaks is required to be undertaken. To ensure the requirement of school wise PTR in Education Districts, transfer of all category of teachers and Siksha Sahayaks wherever necessary is required to be undertaken. Accordingly, Govt. have been pleased to reconstitute the Transfer Committee headed by Collector in the following manner:

For the purpose of rationalization, station seniority shall be taken into account and there shall be no limit of transfer in the existing teachers' strength.

There shall be at least one regular teacher in each Primary School.

Since the inter-se- seniority of the teaching staff of ULB Schools taken by S&ME Deptt. have not been finalized, the transfer of teachers of such ULB Schools will be made within the concerned ULB.

While making rationalisation it should be kept in mind that Teachers/ Siksha Sahayaks having trained graduate qualification shall be posted in schools having higher classes.

The process of transfer shall be completed by 15th June 2010 positively.

All the previous orders issued in this regard are superseded.

You are requested to see that the above guideline is followed scrupulously within the stipulated time.
