DISTRICT PROFILE

ADMINISTRATIVE STRUCTURE:

The administrative head of the district is Collector with it's headquarter at Nayagarh. It has also one subdivision namely, Nayagarh having one Sub-Collector. The district has 8 nos. of blocks and 2 nos.of N.A.Cs namely, Nayagarh, Odagaon, Ranpur, Bhapur, Khandapada, Gania, Dasapalla and Nuagaon ,Khandapada N.A.C, Nayagarh N.A.C. The district has 4 nos. of Tahasils namely, Khandapada, N.A.C., Ranpur, Dasapalla and Nayagarh. The B.D.O.s are the key personals for all kind of developmental works. There is one district office for education; District Inspector of Schools and one District Project Office of "Sarva Siksha Abhiyan" to enlighten the education scenario. The details of the administrative structure of the district are reflected in a separate sheet.

DEMOGRAPHIC PROFILE

The district covers an area of 3890 sq. km. and as per 2001 census of India, it has a population of **8, 64,516.** The district covers a higher percentage of rural area, which includes 97.3% of the total population where as the district has only two NACs named as Nayagarh NAC & Khandapada NAC that includes only 2.66% of the total population. The SC population of the district is 14.04% where in the ST is 5.88%. The rural female literacy rate of the district is 55.37%. The distribution of population in the district is given below.

LITERACY FIGURE


