RESOLUTION

Sub: Revision of pension/Family pension of the primary School teachers who retired during the period from 01.04.1985 to 04.09.1989.

School & Mass Education Department Resolution No-14825/SME dtd.22.07.08 in Para -2 contains the decision for full pension to the pre 01.01.1996 Pensioners / Family Pensioners who were teaching and non-teaching staff of Primary Schools and became Govt. employees w.e.f 05.09.1989 relatable to the maximum period of qualifying service which shall in no case be less than 50% of the minimum of the pay of the revised pay of scale introduced w.e.f. 01.01.1996 for the post last held by the pensioners on the date of retirement. Similarly w.e.f. 01.01.1996 family pension of such pre 01.01.1996 family pensioners shall not be less than 30% of the minimum pay in the revised pay of scale introduced w.e.f 01.01.1996 for the post last held by the pensioners / deceased Govt. servants. However pension will be suitably reduced proportionately where the pensioners has put in less than the maximum period of qualifying service required for full pension as per the rules applicable to the pensioner as on the date of his / her superannuation / retirement.

The question of extending the said benefits to the pensioners retired prior to 04.09.1989 was under active consideration of Government. After careful consideration the State Government have been pleased to decide that revision of pension of retired teachers of Non-Govt. primary Schools who have retired during the period from 01.04.1985 to 04.09.1989 shall be linked to the minimum pay of the post as provided in ORSP Rules, 2008 with prospective effect keeping in view relevant stipulations and coordination prescribed in the above refered Resolution.

The Controller of Accounts /AG (A&E), Odisha is hereby authorized to revise pension of such retired teachers of non-Govt. Primary Schools without awaiting any revised sanction order of pension from the pension sanctioning authority.

On receipt of applications for revision of pension directly from the pensioners (copy at Annexure-I) the Controller of Accounts will verify the service particulars of the pensioners.

This will come in force with to effect from the date of issue of the order.
