No.IX-SME(Sch.)-7/14- 4336 /SME Dt. 1.3.14


Sub : Release of Grant-in-Aid to Private Educational Institutions as per GIA Order, 2013.

The Odisha Education (Payment of Grant-in-Aid to the High Schools, Upper Primary (ME) Schools, Sanskrit Tols and Madrasas) Order, 2013 came into effect w.e.f. 01.04.2013.

It has come to notice of the Government that, some notified High Schools are not fulfilling the eligibility criteria to receive Grant-in-Aid as per the provisions of Grant-in-Aid Order, 2013. Besides, new privately managed recognized High Schools are deprived of getting Grant-in-Aid due to non fulfillment of the eligibility criteria as per provisions of Grant-in-Aid Order, 2013.

Considering the hardship faced by the affected schools, Government after careful consideration have decided :-

- (i) To release Grant-in-Aid salary of the notified High schools other than 110 Girls High Schools category, @60% of grants for one year in relaxation of para-6(c)(d)(e) of Odisha Education (Payment of Grant-in-Aid to the High Schools, Upper Primary (ME) Schools, Sanskrit Tols and Madrasas) Order, 2013. However, the schools under the category of 110 Girls High Schools may be provided with grant equal to the amount what they were receiving before the implementation of GIA order, 2013.

- (ii)** To extend Grant-in-Aid to new recognized private High Schools eligible upto 31/03/2013 in relaxation of the criteria under para-6(c)(d)(e) of the Odisha Education (Payment of Grant-in-Aid to the High Schools, Upper Primary (ME) Schools, Sanskrit Tols and Madrasas) Order, 2013 to the following extent :-
- (a)** Minimum number of students in each class may be 30 in Non Scheduled Areas and 20 in Scheduled Areas.
- (b)** Relaxation of the criteria regarding infrastructure for the year 2013-14 and 2014-15 (i.e. not beyond 31.03.2015).
- (c)** The above two relaxations will come into effect for payment of Grant-in-Aid w.e.f. 01/03/2014.
- (d)** The amendment of the relevant provisions of the Act on the above relaxations for specific time limit shall be taken up accordingly.






