No.VI-SME-(B) 60/2013 ⁴³⁴⁶/SME Whereas the draft of certain rules further to amend *the* Odisha Aided Educational Institutions' Employees' Retirement Benefit Rules, 1981 was published as required by sub-section(1) of section 27 read with sub-section(1) of section 10 of the Odisha Education Act.,1969 (Odisha Act. 15 of 1969), in the extraordinary issue No.2438 of the Odisha Gazette, dated the 10th December,2013, under the notification of the Government of Odisha in the School and Mass Education Department No.28449, dated the 10th December,2013 as SRO No.737/2013, inviting objections and suggestions from all persons likely to be affected there by, till the expiry of a period of thirty days from the date of publication of the said notification in the Odisha Gazette ;

And whereas objections and suggestions received during the stipulated period in respect of the said draft have been duly considered by the State Government.;

Now, therefore, in exercise of the powers conferred by section 27 of the said Act, the State Government do here by make the following rules further to amend to Odisha Aided Educational Institutions' Employees' Retirement Benefit Rules, 1981, namely:-

1. (1) These rules may be called the Odisha Aided Educational Institutions' Employees' Retirement Benefit (Amendment) Rules, 2014.

(2) They shall come into force on the date of their publication in the Odisha Gazette.

2. In the Odisha Aided Educational Institutions' Employees' Retirement Benefit Rules, 1981, for clause (f) of sub-rule (1) of rule 2, the following clause shall be substituted, namely:-

" Pension Sanctioning Authority means *the Block Education Officer in case of employees of Primary Schools and Upper primary schools ; District*

Education Officer in case of employees of High Schools, Sanskrit Tols and Madrasas; and Director Higher Education, Odisha in case of employees of colleges".
