Reference is invited to this Department Letter No.27370/SME dtd.29.11.2013 wherein it was stipulated to continue drawl through old Book of Drawl until a cut of date is intimated by this Department. In the meantime, DDO codes have already been issued in favour of most of the BEOs from the Office of AG,Odisha except a few. 
