3. The intending bidders should submit their quotation in the O/o Under Secretary to Government (OE-B), Revenue & D.M. Department during the office hours on or before the prescribed date and time. The quotation received by Post/Speed Post/Registered Post/Courier or otherwise will not be entertained. The tenders received shall be opened on the same day i.e. **on 26/03/2021** in the Office Chamber of the Additional Secretary (OE-B) in presence of tenderers or their authorised agents. If this day is declared as a Government holiday the tenders will be received and opened on the next working day as per the scheduled time.

4. The Vehicle will be available for inspection **between 11.00 A.M. to 4.00 P.M. (time duration) from 18/03/21 to 24/03/21 (date duration)** (prior to quotation submission date) in the presence of Under Secretary to Government (OE-B), Revenue & D.M. Department, Lokaseva Bhawan.



5. Sale will be governed by the following terms and conditions:

- i. The bidder is required to pay earnest money of Rs. 2000/- with the sealed quotation.
- ii. Earnest money is payable by means of Demand Draft drawn in favour of the "DDO-cum-Under Secretary to Government (Accounts), Revenue & D.M. Department payable at UCO Bank, Secretariat Branch". Bhubaneswar.
- iii. Quotations received without demand draft towards Earnest Money will not be considered as valid quotation and shall not be accepted.
- iv. Successful bidder will have to deposit full bid amount by means of Demand Draft drawn in favour of the "Under Secretary to Government (Accounts), Revenue & D.M. Department payable at UCO Bank, Secretariat Branch" Bhubaneswar within two working days of the acceptance of the bid.
- v. The Earnest Money of the successful bidder will be released only after he deposits the sale proceeds. Earnest money will be forfeited if he fails to honour the bid.
- vi. The sold vehicle will be removed by the successful bidder within **48 hours** of depositing the money and at their own expenses.
- vii. The vehicle will be disposed of on "as is where is basis" and no guarantee for its worthiness of quality will be given by this Department.
