Sub-Contractual engagement of retired employees as Legal Consultant in the Department of Agriculture & FE.

Applications are invited from interested retired officers in the rank of Law Officer / retired OSS /retired ORS /retired OAS/ retired Odisha Legal Service officers well versed with court cases and legal matters for contractual engagement as Legal Consultant (One post) in the Department of Agriculture & FE against the vacant post of Asst. Director (Law) in the Directorate of Agriculture & FP, Odisha, Bhubaneswar in accordance with GA & PG Department Resolution No. 23750 dated 27.08.2014 & F.D O.M No. 24533 dated 29.09.2022.

- The contractual engagement shall be made for a period of one year or till the post is filled up by the Home Department on a regular basis whichever is earlier.
- 3. The eligible criteria of candidates for appointment as Legal Consultant on contractual basis shall be as follows:-
- a) should have the qualification of Bachelors' Degree in Law from a recognised University;
- should be below 65 years of age and physically fit to discharge his/her duties;
- should have good service records;
- d) should have no Disciplinary Proceedings or Vigilance Case or criminal cases instituted against him/her during his/her service period;
- should not have been penalized for misconduct during the last 5 years of his service;
- should not be a member of a political party.
- 4. The consolidated remuneration of the contractual employee shall be at the rate prescribed in F.D O.M No. 24533 dated 29.09.2022.
- 5. The period of contractual engagement shall not be counted as Govt. service for the purpose of pension and any other retirement benefit.
- 6. The engaged officer shall be subject to and abide by the prescribed Conduct Rule as applicable to the Govt. servant and his/ her re-employment can be terminated at any time by the appointing authority due to unsatisfactory performance of the re-employed officer by

giving one month notice. On the contrary, if the re-employed officer desires to resign, he/she shall do so by giving one month's written notice to the competent authority.

- 7. The applicant shall furnish an undertaking at the time of joining the duty in regard to the truth and correctness of the information furnished by him/her. He/ she shall have to furnish the prescribed undertakings and such other documents as may be required.
- 8. The competent authority reserves the right to reject any or all applications without assigning any reasons thereof.
- 9. The applications with necessary bio-data in the prescribed proforma which is available in the Departmental Website https://agri.odisha.gov.in should be addressed to the Principal Secretary to Govt., Department of Agriculture & Farmers' Empowerment and should reach within 15 days from the date of publication of the Advertisement by hand or by post positively.
