ST & SC Dev., M & BCW Department, Government of Odisha invites Request For Proposal (RFP) from reputed agencies empanelled by the Odisha Space Application Centre (ORSAC), Bhubaneswar for undertaking complete assignment on turnkey basis to prepare and file the Forest Diversion Proposals including all related activities thereof leading to forest clearance in favour of ST & SC Development Department and to facilitate in filling of Forest Diversion Proposals by the User Agencies (District Welfare Officers of the concerned Districts) on behalf of ST & SC Development, M& BCW Department, Government of Odishaand obtaining Forest Clearance in respect of the area of land identified for construction of EMRS (Ekalavya Model Residential School) from the Ministry of Environment, Forest & Climate Change (MoEF& CC) Govt. of India(Forest Clearance) under Forest (Conservation) Act, 1980.

- Agencies having experience in completion of minimum of 15 no's of similar types of work in last two years and having capacity for providing such services need only to apply for the above services. The agency whose EMD has been forfeited for failure to complete the assignment in time or some other reasons, shall not apply.
- 2. - 4. The interested bidders are requested to attend the pre-bid meeting scheduled on 18.11.2023 at 11.00 AM in the Conference Hall of office of OMTES, Adivasi Exhibition Ground, Near Shishu Bhawan Square, Unit-I, Bhubaneswar,Pin-751009, for any clarification in the matter. The queries if any relating to the bid document should be sent by email one day before the date fixed for pre-bid meeting. - 5. The bid should consist of conceptual proposal, credential of the agencies; turn over, GST registration and all other documents as mentioned in the bid document. The financial bid for the proposal should clearly reveal the cost of undertaking such complete assignment on turnkey basis for unit extent of area i.e. cost per hectare as per the specified format. All prices should be quoted, excluding statutory fees and GST, in Indian rupees.
- **6.**The bidders are requested to submit their Bids by 5.00 PM of 29.11.2023 through Speed Post/Registered post only addressed to "The Secretary, OMTES, Adivasi Exhibition Ground, Near Shishu Bhawan Square, Unit-I, Bhubaneswar, Pin-751009. - **7.** The agencies shall be engaged for a period of 6 (Six) months for completing the assignment. It may be considered for extension, if required, subject to satisfactory reasons conveyed by the agency.
- **8.** The Secretary, OMTES shall have the right to accept or reject, any or all the RFPs, without assigning any reasons thereof.

For undertaking complete assignment on turnkey basis to prepare and file the Forest Diversion Proposal including all related activities thereof leading to forest clearance in favour of ST & SC Development, M&BCW Department and to facilitate filling of Forest Diversion Proposals by the User Agencies (District Welfare Officers) and obtaining Forest clearance in respect of the area of land identified for construction of EMRS(Ekalavya Model Residential School)on behalf of ST & SC Development, M&BCW Department, Odisha from the Ministry of Environment, Forest & Climate Change (MoEF& CC) Govt. of India(Forest Clearance) under Forest (Conservation) Act, 1980.

The main objective of the contract is for preparation and filing of Forest Diversion Proposals following due process of law.

Formats for submission, Terms of Reference (TOR) and Performance Specifications are enclosed. TOR describes broad scope of work and should guide in submission of the offer.

## (1) Proposal Conditions

- (a) This Tender Call Notice is not an offer to contract but represents adefinition of specific requirements and an invitation to recipients to submit a response addressing such requirements. Issuance of this Tender Call Notice, preparation and submission of a response by the bidder and the subsequent receipt and evaluation of the response by OMTES, does not commit OMTES to award a contract to any bidder, even if all of the requirements stated inthe Tender Call Notice are met.
- (b) If a bidder (agency) is selected, the bidder must be able to commence the work immediately within 15 days after the award of contract.
- (c) OMTES may modify these requirements in whole or inpart and / or seek additional information if required. Only the execution of a written contract will obligate OMTES in accordance with the terms and conditions contained in such a contract.
- (d) OMTES shall not, in any way, be liable for any costs incurred by the respondents in preparing a response to this Tender CallNotice or during subsequent discussions with OMTES regarding their bids.
- (e) All information contained in this Tender Call Notice shall be considered "Confidential Information". As such, the confidential information shall be protected and maintained in strict confidence by all the recipients of such information and shall not be disclosed or disclosure allowed by the bidder, except for the sole purposes of responding to this Tender Call Notice.



(f) In the event that disclosure of the Confidential information to employees and authorised agents is necessary, Confidential Information may be disclosed to them on a need-to-know basis, but the bidder shall make these persons aware of the confidentiality of such information and they shall (and the bidder shall cause them to) be bound by the terms and conditions of this Tender Call Notice.

(g) In no event shall this document, or any subsequent documents that may be made available in connection with this Tender Call Notice, be copied, transcribed, or distributed in whole or in part without the specific prior written authorization of OMTES. OMTES reserves the right to require the return or destruction of all documents including extracts, summaries and related notes.

(h) All access to OMTES & ST & SC Development, M & BCW Department websites shall be subject to OMTES & ST & SC Development, M & BCW Department security procedures, Code of Conduct, confidentiality provisions and health and safety rules. OMTES reserves the right at its absolute discretion to exclude and or refuse access to any of its sites to any personnel including but not limited to bidder's staff and or agents. (2) Who Can Bid?

(a) Only ORSAC empanelled agencies, who have not been black listed and having experience incompletion of minimum of 15 no's of similar types of work in last three years and having capacity for providing such services need only to apply for the above work.

(b) The agency should have ISO 9001:2000 or latest updated version of the Certification in preparation of Forest Diversion proposals & follow the rules regulations and laws in this regard.

## (3) Essence of the Contract

The basis of consideration and the essence of the contract shall be strict adherence to the quality and performance specifications for performing the works/ services during the period of contract. The performance and quality specifications set out in this document shall be the basis of evaluation of offers.

## (4) Submission of Bids

(a) The tender has been invited under two bid system namely, "Technical Bid" and "Financial Bid". The interested bidders are advised to submit two separate bids in two separate sealed covers with superscription on the cover as "Technical Bid for preparation and filing of Forest Diversion Proposals" and "Financial Bid for preparation and filing of Forest Diversion Proposals". Both the said sealed covers should be kept inside the main sealed cover, which should reach by the scheduled date and time.

#### (b) Technical Bid:

The Technical Bid to be submitted shall comprise the following as per formats enclosed in Annexure-A of Appendix-I, failing which the bid will be summarily rejected and will not be considered any further.

- (xiii) EPF Return for last 2year.
- (xiv) ESI Registration Certificate.
- (xv) Certified Extracts of the Bank Account containing transactions during last 3
- (xvi) An undertaking to the effect that no case is pending with the police against the bidder and the bidder has not been black listed.
- (xvii) Letter of Authorization for attending bid opening in the letter headof Agency (in the given format).
- (xviii) Any other documents as required under this Tender Call Notice.
- (xix) Details of Technical man power with qualification and experience.

#### (C) Financial Bid:

The Financial Bid shall be submitted in sealed cover asper formats enclosed in Annexure- B of Appendix-2 and shall comprise the financial quote.

## 5. Bid preparation cost:

The cost of preparing the bids, presentation and of negotiating the contract including site visits etc. will be borne by the bidders themselves and in no case will be reimbursable by OMTES.

#### 6. Local Conditions:

It will be imperative on each bidder to fully inform himself of all local conditions and factors, which may have any effect on the execution of works / services covered under these documents and specifications. Intending Bidders shall visit the site and make themselves thoroughly acquainted with its local site conditions. It must be understood and agreed that all the factors have properly been investigated and considered while submitting the bids. No financial adjustment arising thereof shall be permitted by OMTES, which are based on lack of such clear information. Further, no claim for financial adjustment to the contract awarded on these specifications and documents will be entertained by OMTES.

#### 7. Price Bids:

The bidders are required to quote amount inclusive of all prevailing taxes and fees except the statutory fees and GST for preparation and filing of Forest Diversion Proposals in the prescribed format. The total amount to be quoted in Indian rupees shall befor the first full year of the contact starting from the date of commencement of services. The fee shall be payable in 12 equal monthly instalments. OMTES may consider escalation over subsequent year, if required, to compensate increase in minimum wages, inflation etc. The contract shall be valid for a period of six months and would be extendable subject to further requirement and satisfactory performance at the discretion of the OMTES. In addition, the statutory GST if payable shall be paid separately on submission of proof of payment to the Government.

The bidders are required to consider all the costs, consumables, tools and equipments except for providing the services.



#### 8. Language:

All information in the bid shall be in English. Information in any other language shall be accompanied by its translation in English. Failure to comply with this requirement shall disqualify a bid. In the event of any discrepancy in meaning, the English language translation of all documents shall prevail.

## 9. Signature of the Bidder:

The bid must contain the name, residence and place of business of the authorized person/ persons/ organization & the bid must be signed by the Bidder with his usual signature. The names of all persons signing shall be stamped, typed or printed below the signature. Bids by Corporation/ Company must be signed with the legal name of the Corporation/ Company by the President/ Managing Director or other person or persons authorized to bid on behalf of such Corporation/ Company in the matter.

## 10. Vague and Indefinite Expressions:

Tender documents submitted by the bidders containing vague and indefinite expressions such as "subject to availability" etc. will not be entertained. Full responsibility is to be accepted by the bidder.

## 11.Bid submission:

Bidders are advised in their own interest to ensure that the bids must be submitted through Speed Post only and must reach well before the closing date and time of Bid Submission. The tender inviting authority shall not be responsible for any postal delay.

## 12. Equal Information Policy:

If any bidder raises a question, which is considered to be in general interest, OMTES reserves the right to circulate both question and answer to all other respondents/ bidders. In this event, the identity of the bidder(s) raising the issue will not be disclosed.

## 13. Earnest Money Deposit (EMD):

The bidders are required to pay an Earnest Money Deposit (EMD) of Rs.2,00,000/-(Rupees Two Lakh) only in the form of demand draft in favour of Secretary, OMTES, payable at Bhubaneswar.

The bidders are required to pay the cost of "Non-Refundable Process Fee" of Rs.2,000/- (Rupees Two Thousand) only in the form of demand draft in favour of Secretary, OMTES, payable at Bhubaneswar.

The D.D. for EMD and cost of Non-Refundable Process Fee must be submitted in a separate envelope addressed to "The Secretary, OMTES". Any bid without EMD and Non-Refundable Process Fees (and copy of Tender Document) shall be liable for rejection. The amount of EMD shall not carry any interest.

#### 14. Return of EMD:

The EMD paid by the unsuccessful bidders will be refunded to them without interest, after the award of work is finalized by OMTES. The EMD for the successful bidder shall be returned only after completion of work in all respect.

## 15. Bid validity period:

The price quoted by the bidders shall remain unchanged till the completion of the assignment. In case the bidder withdraws, modifies or changes his offer during the bid validity period, the Earnest Money Deposit shall be forfeited without assigning any reason thereof.

## 16. Right to Accept or Reject any or All Bids:

- 16.1 The OMTES reserves the right to accept or reject any or all bids without giving or assigning any reason for his decision. The work maybe assigned to one or more selected bidders at the lowest bid amount quoted keeping in view the exigencies of work. However, the L1 bidder shall get preference in such case.
- 16.2 Tenders are liable to be rejected in case any of the particulars / prescribed information is either missing or incomplete in any respect and / or if the prescribed conditions are not fulfilled.
- 16.3 Canvassing in connection with the tender is strictly prohibited and proposals submitted by bidders who resort to canvassing will be liable for rejection.
- 16.4 Evaluation of bids shall be at the sole discretion of OMTES and no suggestion and / or communication shall be entertained in this regard. OMTES reserves right to reject or accept and to annul the bidding process and reject all the bids at any time prior to the award of contract, without thereby incurring any liability to the effected bidders or any obligation to inform the affected bidders of the ground for OMTES action.



## 17. Examination of Bids:

OMTES will examine all the bids to determine whether they are complete in all respects as specified in the Tender Documents supplied to the bidders. Examination of Bids shall be done in two stages as below:

#### 17.1 Technical Bid:

Technical bids received will be opened on the scheduled date and time. This bids' will be examined as per the terms of reference, specifications and documents, mentioned in this Tender Documents to ascertain the qualified bids. The bidder should take enough care to submit all the information sought by OMTES in the desired formats.

#### 17.2 Financial Bid:

The Bidder will quote amount for conducting the assignment. The price Bid is to be provided in the formats given in Appendix-2. Significant lack of clarity on any cost of item as called for above could lead to the bid being rejected, if it hinders a uniform evaluation process, even if the bid meets all other bidding and technical criteria.

Those bidders who will be successful in their Technical Bid shall only qualify for consideration of opening of Financial Bids. Financial Bids of all qualifying bidders will be opened for which intimation will be given to all pre-qualified bidders who if they so desire, can remain present.

## 18. Successful Bidder:

The L1 Bidder found, will be the Successful Bidder (Agency). In case of multiple Bidder tied up in L1 price, then the maximum average annual turnover will be taken into consideration for selection of L1 Bidder.

## 19. Service Agreement:

The successful bidder would be invited to execute the Service Agreement, which would have, apart from others, the specific conditions as presented in **Annexure-A**.

## Specific Condition of the Service Agreement

#### AGeneral Conditions

- 1. The Persons deployed by the Agency must be properly trained and possess requisite experience and skills for carrying out preparation and filing of Forest Diversion Proposals. Non-compliance of any statutory requirement will lead to the termination of the contract.
- 2. The agency will have to commence the work within 15 days of acceptance of contract. Otherwise the contract will be cancelled and EMD will be forfeited.
- 3. The task should ideally be completed within a period of six month. As such the contract shall be valid for a period of six month. However it may be extended further if required subject to satisfactory performance and valid reasons if any. The rates quoted by the Agency shall remain unchanged. The OMTES however reserves the right to terminate the contract by serving one month notice in writing to the agency. The contract may also be terminated with mutual consent by giving one month's notice.
- 4.In case of breach of any terms and conditions attached to this contract, the EMD of the agency will be liable to be forfeited by Secretary, OMTES besides annulment of the contract.
- 5. The agency shall not delegate or entrust the work to any other party.
- 6. The Secretary, OMTES reserves the right to withdraw / relax /amend any of the terms and conditions mentioned above without assigning any reason there of so as to overcome any problem that may arise at a later stage.
