House Building Advances and Motorcycle Advances are being sanctioned by Departments of Government and Heads of Departments in favour of the Government servants as per Resolution No. 21246/F, dated 22.06.1959 and 46351/F, dt. 09.09.1980 of Finance Department respectively.

A huge number of employees are working under the administrative control of Block Education Officers of the State as Assistant Teachers, Graduate Teachers, Headmasters and staffs in the said offices.

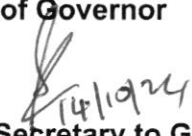
After decision taken by Government for drawal of House Building Advances (HBA)/Motorcycle Advances (MCA) from the Global allotment, a good number of employees working under the Block Education Officers are submitting their applications for sanction of such advances in their favour. But the existing infrastructure of the Directorate of Elementary Education is not sufficient to process the applications and sanction the same in favour of the employees in due time.

Keeping in view of the above facts into consideration, Government have been pleased to delegate the existing powers to the Regional Directors of Education (RDEs) under School & Mass Education Department for sanction of House Building Advance / Motorcycle Advance in favour of the Teachers, Headmasters and employees working under the Block Education Office.

Therefore, the Block Education Officer will process the applications received from the employees under his administrative control for such long-term advances (HBA/MCA) and forward the same to the respective Regional Directors of Education (RDEs) for sanction of the same in favour of the employees as per the existing Guidelines.

This has been concurred in by Finance Department in their File No.FIN-SOS1-ADV-0002-2023.

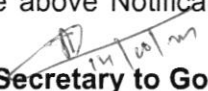

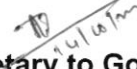
