- v. A/C Belt and Dynamo Repair/Replacement


The price quoted shall be clearly indicated, including G.S.T. Separate quotations shall be submitted for repair work and replacement of spare parts.


The Government-approved garage shall furnish a guarantee certificate in respect of major repairs carried out on the aforesaid vehicle.






