**Notice Inviting Tender**  
**e-Procurement Notice No- CE&BM-MB-42/2025-2026 (Online)**

1. The Chief Engineer & Basin Manager, Mahanadi Basin, Burla on behalf of Governor of Odisha invites on-line percentage rate tenders in double cover system through e-procurement for execution of the works noted below. The bid should be submitted by eligible class of contractors as mentioned below registered with State Government & contractors of equivalent grade / class registered with Central Government / MES / Railway to be eventually drawn in P-1 form through On-line in the Government website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in). The bidders should have necessary portal enrolment (with own digital signature certificate). The registered bidders outside Odisha State can also participate in this on-line tender process after necessary portal enrolment but shall have to subsequently undergo registration with appropriate authority of the State Government within a month of acceptance of bid. The bidders registered outside the state are required to submit an undertaking in the form of an affidavit, that they are not registered under the GST Act in the State of Odisha as they have not started any business in the State and they have no liabilities under the Act. But, the successful bidder registered outside the State has to produce GST Clearance Certificate in the form GST before signing of agreement.

EMD Required: The contractor shall be required to deposit 1% of the estimated cost of work tendered for as earnest money while offering tenders (Online) and 1% as initial security deposit / Bid security at the time of acceptance of tender provided in shape of N.S.C. / K.V.P. / Post Office Saving Bank Account / Post Office Time Deposit Account/ Term Deposit Receipt of any Schedule Bank or Nationalized Bank in India counter guaranteed by its local branch at Bhubaneswar duly pledged in favour of the **Superintending Engineer, Bargarh Irrigation Division, Bargarh**, under whom the work will be executed, without which the tender is liable for rejection. The scanned copy of E.M.D./ Bid security will be submitted in web site at the time of submission of bid along with the tender paper.
3. Cost of Bid Document: The Bidder shall transfer online the cost of bid document specified for the work in the Column-6 of above table i.e. Rs 10,000/- through a process as mentioned under DTCN.

5. Tender should be submitted On-line in [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in). Bid document consisting of qualification, information & eligibility criteria of bidders, plans, specification & Bill of quantities of the works are available in web-site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) & the set of terms & conditions of contract & other necessary documents can be seen in the web-site till last date of submission of Bid.
6. Bid validity period of the Tender is for a period of 90 days from the last date of submission of Bid. If any bidder withdraws his Bid/Tender before the said period or makes any modification in the terms & condition of the bid, he/she will be suspended for the time specified in the tender document.
7. Engineers of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government are not allowed to work as a contractor for a period of two years after his/her retirement from Government service, without Government permission.
8. Additional Performance Security (APS) shall be taken on incremental basis from the selected bidder for low bid prices in the project works as under:

I. Where the bid price is below 0% but not below 10% of the project cost put to bid:

No additional performance guarantee/security percentage is required.

II. Where the bid price is below 10% but not below 20% of the project cost put to bid:

The additional performance guarantee/security percentage shall be incremented by 0.1% for every percentage of bid prices below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and this additional performance guarantee shall be applied on bid price.

III. Where the bid price is 20% or more below the project cost put to bid:

The additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid prices below 20% of the project cost put to bid in addition to 1% of the bid price and this additional performance guarantee shall be applied on bid price.


IV. The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.50% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.

The Additional Performance Security (APS) shall be furnished in shape of Term Deposit Receipt pledged in favour of **Superintending Engineer, Bargarh Irrigation Division, Bargarh, Dist.-Bargarh**/ Bank Guarantee in favour of the **Superintending Engineer, Bargarh Irrigation Division, Bargarh, Dist.-Bargarh** from any Nationalized / Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within 7 days of issue of Letter of Acceptance (LoA) by the Divisional Officer (By e-mail) to the successful bidder otherwise his/her bid shall be cancelled. Further, proceeding for blacklisting shall be initiated against the bidder.

If the APS is submitted in shape of Bank Guarantee by the bidder, then the validity of the Bank Guarantee should be for a minimum period equal to the period allowed for completion of the work plus defect liability period of one year & one month extra for transaction period.

9. The following clarification are issued on Works department Office Memorandum No. 173 dated-03.01.2026.
- I. The phrase".... to abolish the extant provisions of threshold negative bid caps (14.99%) introduced....." in the first para of the Works Department OM No. 173, dated. 03.01.2026 may be read as ".... to abolish the extant provisions of threshold negative bid caps of 15% introduced vide Works Department OM No. 12366/W, dt. 08.11.2013 and amended vide Works Department OM No. 1437 dt, 31.01.2023."
  - II. If more than one bid is quoted (decimal up to two numbers will be taken for all practical purposes), either at the estimated cost put to tender or less than the estimated cost put to tender, the tender accepting Authority will finalize the tender through a transparent lottery system, where all the concerned bidders/their authorized representatives, the concerned SE/EE of the concerned Division and Divisional Accounts Officer (DAO) will remain present.
10. The bidders are required to upload the self-attested documents such as (i) Original Contractor's Registration Certificate (CDMS), (ii) valid & active GST Registration Certificate, (iii) Original affidavit regarding authenticity of documents, (iv) No relation certificate, (v) valid & active PAN

- Card, (vi) EMD/Bid Security & (vii) All other required documents as per bid document along with the technical bid, otherwise his / her bid shall be declared as nonresponsive & shall be rejected. The lowest successful bidder only is required to produce documents viz Original Contractors Registration Certificate (CDMS), GST Registration Certificate, Original affidavit regarding authenticity of documents, No relation Certificate, PAN card for verification purpose.
11. Bids received online shall be opened at **11.30 A.M 11.03.2026** in the Office of the Chief Engineer & Basin Manager, Mahanadi Basin, Burla, Dist.-Sambalpur, (Odisha) in the presence of the bidders who wish to attend. Bidders who participated in the bid can also witness the opening of the bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time & venue.
  12. The Bidders should ensure clarity / legibility of the documents uploaded by them to the portal. Non submission of legible documents may render the bid non-Responsive. Further, the bidders are requested to mention their e-mail Id, address & mobile phone number in the Affidavit for correspondence.
  13. The Addendum/Corrigendum if any, will be hoisted in the State e-Procurement Portal i.e [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) only.
  14. Authority reserves the right to reject / cancel any or all the tenders without assigning any reasons thereof.
  15. Registration in the Contractor Data Base Management System (CDMS) available at [www.cdmsodisha.gov.in](http://www.cdmsodisha.gov.in) by all Contractors is mandatory as per O.M No-12934/W dated 23.08.2018 of Works Department, Govt. of Odisha with insertion of provision in Para-12.4 below Para-12 in Appendix-IX(A) of the OPWD Code, Volume-II. The tender will not be accepted or bid will be rejected if not registered under CDMS portal.
  16. Any company or organization participating in the bidding, the authorized person having proper Power of Attorney should have Registration Certificate, PAN No, GST Registration Certificate in his name shall sign the affidavit of authentication of documents and upload the same with the technical bid, otherwise bid will be treated as irresponsible.
  17. Any bidder/bidders desire to appoint power of attorney holder should upload the genuine documents regarding the same with the technical bid failing such a bid will be treated as irresponsible. Any claim in this regard shall not be entertained later on what so ever.
