1. Mode of Engagement:-

Engagement through Open Public Advertisement and selection by an internal Selection Committee constituted by the Department.

2. Vacancy

- The Department reserves the right to cancel the advertisement, change the number of posts, relax age/qualification in deserving cases, or modify terms without assigning any reason thereof.






